MAIN NARRATIVE

On 07/12/15 at about 11:55 a.m., I responded to the Johnson County Jail (278 SW 871, Johnson County, Centerview Mo) for an assault on a Correction Detention Officer. I arrived and learned the victim, CDO [REDACTED] was assaulted by inmate, Grayden Denham. CDO [REDACTED] transported Grayden from the Raytown Police Department, Grayden had received citations for no insurance and driving while suspended and a bond was given for those citations (Grayden also had four active warrants out of the Kansas City Police Department and one active warrant out of the Smithville Police Department). CDO [REDACTED] was completing his transportation process so Grayden could complete the booking process. CDO [REDACTED] had removed the handcuffs and shackles from Grayden, and was conducting a metal detector wand search over the defendant's clothing. CDO [REDACTED] told me he noticed Grayden put his left hand into his front left pant pocket so he reached to the left pant pocket for a pat down. CDO [REDACTED] was bent over at the waist as he checked the pocket, and suddenly Grayden attempted to strike CDO [REDACTED] in the head with his right elbow. Grayden attempted to grab [REDACTED] in a head lock, but missed, so Grayden grabbed [REDACTED] with both hands by the back of the neck and started pulling downward. CDO [REDACTED] was able to break the hold and back away, but Grayden moved towards the [REDACTED] with his hands fisted and up. CDO [REDACTED] and Grayden moved towards each other and grabbed each other but Grayden pulled away. Grayden stood with his fists up until Correction Detention Officer Bryan pointed a pepper spray can towards him, Grayden attempted to take the spray away but missed. CDO Bryan then pepper sprayed Grayden on the left side of his face. After a second attempt to spray Grayden (which hit Grayden on the back of his neck), he ran into a holding cell and the door was closed.

While watching the video of this attack, I could see Grayden smiling. It was also obvious he was protective of his left pocket and placed his left hand in that pocket several times, he also was holding his crotch area several times during this incident. It seemed he may be hiding something on his person. I called Jail Administrator Duvall and asked for a copy of the video showing this incident. CDO [REDACTED] gave a written statement. Inmates present during this incident stated they did not want to complete a written statement.
