****The female African Elephant identified as Lou by the facility representative had a swollen area in the left side of the face with some heavy redish/yellowish discharge been secreted. The elephant was moving around throwing dirt at the side of the head/face and lifting the head which may indicate the she was feeling uncomfortable. The attending veterinarian has not been to the facility to examine the elephant. The owner washed away the discharge but it still looked swollen and additional secretions was observed.

****In order to avoid a serious infection of the affected area the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries must be implemented.

****An exit interview was conducted with the facility representative.
